MEMBERSHIP, ANNUAL FUND CONTRIBUTIONS, AND GRANT FUNDING ARE ALSO VITAL COMPONENTS OF SUSTAINING THE FILSON'S OPERATIONS. THE FILSON STEWARDS COLLECTIONS (LIBRARY, MANUSCRIPTS, PRINTS & PHOTOGRAPHS, AND MUSEUM OBJECTS) WITH SIGNIFICANT CONNECTION TO KENTUCKY AND THE OHIO RIVER VALLEY TO PRESERVE AND SHARE THE HISTORY OF OUR REGION.
