Will of John W. Hundley, 16 October 1829. [Hundley died in September, 1830].

Marginal note: "Will set aside. Admin. Granted Jack Thomas, Thomas C. Hundley on the 4th day of June 1832. See County Court Order Book pages 106, 107".

Deep religious convictions throughout his will: "believing most firmly in the truth of the Christian Religion, I commit my soul to the love and keeping of a sin pardoning God through our Lord Jesus Christ"; mentions his "worldy estate with which God has blessed me".

- 1st After debts and funeral expenses are paid, "...the negroes who may have been fifteen years in my service from the time of their purchase be immediately set free; That those not born mine who may not have completed that length of service shall remain the property of my brother Thomas C. Hundley until the expiration of fifteen years from their purchase and then to be liberated; that all which have been born mine shall be free when they arrive at the age of twenty-five or at the death of my brother Thomas C. Hundley be their age what it may or whatever may have been the term of service of the others above specified; and any child born of a female during the time of her service shall go out free with its mother. None of any description shall remain in slavery after his death".
- 2. Plantation where I live, containing 1168 acres, with improvements to remain with brother Thomas C. Hundley for 2 years after testator's death; then to pass to executors as a fund in trust, "the proceeds to be employed for the cause of God forever". Wanted to establish a theological seminary on the premises "for the purpose of preparing pious young men for the Gospel Ministry and under the direction of the Presbyterian Church". Land then not to be sold but to rest with the seminary trustees. If such a seminary cannot be established on the proerty, then the land and improvements are to be sold. Income from this sale to be held by executors in a trust for education of "pious young men", and income is to be "vested under the Charter of Centre College". Interest only to be used.
- 3. Out of any cash, bonds, etc. on hand at death, \$12,000 to go to brother Thomas C. Hundley. This includes any money owed him by testator.
- 4. \$1000 to American Tract Society of NY to constitute a fund, the interest of which shall be used by the Louisville branch "for the use of the Western Country".
- 5. \$1000 to an Orphan Asylum, already established at Middletown provided that it "shall afford evidence of stability and permanency". Beneficiaries to include black children, "not exceeding five at one time", for up to 2 years.
- 6. Any other funds on hand to go to Education Society of Kentucky, for scholarships.
- 7. To Thomas C. Hundley: 4 horses, watch, gig, bed, secretary, bookcase, booksand all wearing apparel.
- 8. Brother Joel W. Hundley: choice of horses.

9. before dividend of this legacy at interest is made, \$500 of this money "be applied to the purchase and freedom of a black man named Daniel Curtis now in slavery near Woodville, Mississippi. If he cannot be purchased the money shall be given to himself, but if he is dead, then the money shall be given to the Education Society as part of a scholarship".

10. Remainder of stock, farm equipment, furniture, etc., after remaining with Thomas C. Hundley for 2 years, is to be sold. \$1500 of this income, be put in a fund, the interest from which is to be paid annually to brother

Elisha E. Hundley. \$1000 from this sale is to be paid directly to brother Joel W. Hundley.

11. Tract of land in Washington Co. where Elisha E. Hundley lives is to be enjoyed by him during his lifetime CODICIL, 16 October 1829: If a seminary is established on the property, Thomas C. Hundley may use the bedroom, firewood, stable and pasture. He also receives testaor's rifle "as a special token of my affection". CODICIL, 16 October 1829: All slave children not "born mine", and not 25 at his death, to go to Thomas C. Hundley until they are 25. Sam, whose name was Henry when Hundley bought him as a child, and is now 16, is given to Thomas C. Hundley until he is 30, and then is to be emancipated. Mary, whose name was Sally when Hundley bought her as a child, and is now 8, given to Thomas C. Hundley until she is 21 and then to be

emancipated. At his death, all slaves to be emancipated, regardless of time of service.

OM 16, p. 106, 9 May 1832

On motion of Jack Thomas and Hundley's heirs, the following decree from Oldham Co. Circuit Court, May Term 1832, was recorded: In the case of Hundley's heirs vs. Andrew Cunningham and Hundley's executors, with Benjamin Hardin attorney for the plaintiffs: the KY Court of Appeals affirmed May Term 1831 decision of Oldham Co. Circuit Court, setting aside the will, except for the slaves Jacob, Nilson, James Terrill, David and Cato. Their portion, which emancipated them, was upheld. Jefferson Co. Court then set aside Hundley's will and codicils and appointed Thomas C. Hundley (John W. Hundley's brother) administrator of the estate.

Hundley dec'd for my services since my freedom up to the day of his death being upwards of five years and they are authorized to compromise and claim for whatever they may think proper and out of that sum they may receive they are authorized to retain one half for their trouble and services in attending to the business...Guthrie and Tyler to pay all costs and expenses and I am to receive one half of what may be recovered". Witnessed by Joseph Funk.

Trespass in assumpsit. She sought damages of \$2000.

On 4 March 1840 the court awarded her \$500 in damages.
