I am enclosing a letter from the commissioner of Interior and attached papers which advise me of the serious crists which has arisen in connection with the water supply of the town of Juana Diaz. As you know the entire matter of water supply of this city has been wholeyounsatisfactory for several years and that House Juint Resolution 26 was introduced for the purpose of providing a permanent remedy.

The Commissioner of Interior suggests that a substitute for this Joint Resolution might be immediately passed by the Legislature which would provide not only an immediate remedy for the present crisis but also solve the problem of a permanent water supply of the city. The Commissioner also states that this substitute for House Joint Resolution 20 will be immediately introduced.

Indemuch as it provides for an expenditure of Insular funds of only fifteen thousand dollars (\$15,000) and inasmuch as the Commissioner of Interior recommends it as feasible and practicable not only for the immediate present but also for the future I recommend that this substitute be considered and

passed by the House at the earliest practicable moment.
