MINUTES LUNCHEON MEETING April 9, 1927

Luncheon Jeeting April 9/27.

The regular luncheon maeting of the Women's City Club was held in the ball room of the Kentucky Hotel on Saturday, April 9, at 12:15.

Mrs. A. A. Krieger, the president, presided.

Minutes read.

The minutes of the last regular monthly meeting were read and approved.

Treasurer's report.

The Treasurer's report was read and approved. A copy may be found attached to these minutes.

Chairman of Health Com. introduces Dr. Graves. Mrs. Wischmeyer, Chairman of the Health Committee was in charge of the program. She introduced Dr. Stuart Graves, whose subject was "Our City Hospital."

Dr. Graves speaks on the City Hospital.

Dr. Graves stated the common conception of a hospital to be a nursing home, an institution that exists solely for the purpose of taking care of the sick. He explained its object as three fold, viz.

- 1. The care of the sick
- 11. To function as a training institution for doctors and nurses.
- 111. To promote, encourage, and subsidize the proper kind of investigation between doctors and nurses, that out of this co-ordination, new discoveries may result to alleviate human suffering.

In commenting upon these objectives, the speaker pointed out that, besides caring for the sick, it is the duty of the hospital to teach the patients preventive measures wherever possible; to teach them also how to live. He advocated the grouping of private hospitals around a central medical school, which he said, is the method used in the progressive cities.

Our city hospital is better run, he said, at present, than ever before. The patients are well and humanely cared for, the place is clean, the food good, the equipment fair. He enumerated the great needs as follows:

- 1. A new dispensary building.
- 11. A Social Service Department to work with the home, the homeital, and with all

- the social agencies of the city.

 111. An institution, located preferably in
 the country, where incurables and
 convalescents can live and work in
 the open.
- ly. A room for Nurses.
 - W. A room for House Doctors.
- Vl. A new Contagious Hospital.
- Vll. A Tuberculosis Evacuation Ward

The yearly budget he explained is made out under three heads, as follows:

- 1. The Absolutely Essential.
- 11. The Badly Needed.
- 111. The Highly Desirable.

Needless to say, the first named only is granted.

He made a plea for good will and understanding on the part of the public, which, he explained, can do much toward securing necessary funds.

The business of the morning followed.

Miss Morel made a report upon the plans for the Flower Market and named the chairmen of committees.

She reported also, upon cleaning up day on the point, which she said met with great success.

Miss Breed reported upon the status of the City Planning & Zoning interim ordinance.

Her report follows:

which we have been so long interested has been twice before the Boards of the City Council and has twice been referred to a committee.

The ordinance creating a City Planning & Zoning Commission has already been passed.

The present ordinance is an interim ordinance designed to take care of conditions until such a time that the Commission can be appointed and organized, can make a survey and a comprehensive plan and submit a report.

"We have offered to attend the Council meeting but were told we were not needed. Now however, we will be welcome at the meeting on April 19th when the Committee reports again.

"Opposition has developed to this interim ordinance, prominent in this is a woman member - quite a large number of opponents to the measure appeared at the last hearing - therefore - the City Planning & Zoning Committee invite the members of the City Club to go to the Council Meeting April 19th in support of this ordinance.

"We further recommend that a letter be sent each member of the two boards in the name of the City Club urging the favorable action at this time upon the City Planning & Zoning interim ordinance."

Suggestions for chairmen of various committees were made and discussed but no action was taken.

The request made by Mrs. Newman and presented at the last Board meeting, that the City Club take charge of the booth of the National Plant, Flower and Fruit Guild, one day a month, was again presented for action. It was moved by Miss Voegtle (Mrs. Gilbert) that action on the part of the Club be postponed until the president has had time to confer with Mrs. Newman to learn of her plans and what is asked of the City Club.

Mrs. Peak & Mrs. Edw.Mayer appointed on Recreation Council of Com. Chest.

In answer to a request from the Recreation Council of the Community Chest that two delegates be appointed to represent the City Club on the Council, it was voted to appoint Mrs. Peak and Mrs. Edward Mayer.

Financial Statement presented by Miss Gesner.

The financial statement of the club for the coming year, on the basis of estimated dues, income, and expenses was presented by Miss Gesner, and may be found in detail attached to these minutes. main points stressed were that the report showed clearly that \$500 additional are needed yearly to operate: that the disbursements are as low as they fan possibly be, and that an increase in membership would help solve the problem of finance. No action was taken, the understanding being that a copy of the statement be left at the club rooms where each member can see and familiarize herself with its contents.

Mr. Johnson Speaks on affirmative side of Bridge Bonds. The regular monthly luncheon meeting of the Louisville Women's City Club was held in the ball-room of the Brown Hotel on Saturday, October 8th.

The Secretary's report was read and approved, also the treasurer's report. A copy of the latter may be found attached to the Secretary's files.

The meeting was turned over to Mrs. Cheney, Chairman of the Legislative Committee. Mrs. Cheney explained that the legislative questions before the house included;

1. Two Bond issues, namely:

(a) The proposed 5,000,000 Bridge Bond Issue.
(b) The proposed 1,500,000 Park Bond Issue.

ll. Two proposed Constitutional Amendments, viz.,
(a) The Removal of Limitation of Salaries
of Public Officials.

(b) The Absent Voter.

Speakers were limited to four monutes.

Mr. Henry Johnson s oke on the affirmative side of the proposed Bridge Bond. His points were

1. The bridges now crossing the Chio are inad-

equate for vehicular traffic.

11. Louisville, because of its geographical position, is the gateway to the south and should provide and easy and unbroken passage from the excellent roads in the states to our north and east, to those at our south.

111. Such a bridge as is proposed will add to the industry, wealth, and population of the city.

lV. Louisville rates the lowest of 23 cities of its approximate size in its percapita bonded debt.

V. The way to delvelope a city is to pay as you go.

VI. The excellent citizens composing the Bridge Commission are a guarantee against graft.

VII. The best engineers of the country have estimated the cost, and their estimates have, in the past been trustworthy.

VIII. It is believed by the engineers that the tolls will, in 10 years, pay for the bridge, though their calculations have been based upon the more conservative figure of 30 years.

Mr. Moxley speaks speaks for the opposition.

Mr. Moxley for the opposition, made the following points:

1. Bridges are built under contracts on the private ownership plan more cheaply than under the municipal ownership plan.

- 11. The cost of building under the bond issue plan is uncertain - it may be \$5,000,000, it may be \$6,000,000; it may be more. The private ownership plan definitely fixes the price.
- 111. The graft danger is more of a factor in the municipal ownership plan than in that of private ownership.
- lv. Under the private ownership plan there is no increase in the tax rate, no payment of money down. At the end of 20 or more years, as has been agreed upon, the private corporation turns over the bridge to the city at the cost of construction minus the depreciation. Why, then, the bond issue.

MNs. Settle explains the proposed amendment tion of Salaries of Bublic Officials.

Mrs. Settle spoke on the amendment which proposes to remove the limitation upon salaries of public officials, an amendment which has already been favoron Removal of Limita ably woted upon by the accredited delegate of the City Club at the Paducah Convention. The points made by Mrs. Settle were:

- 1. Salaries of public officials should bear some relation to the size of the community, the wealth of the community, the responsibility which the position cabries, etc.
- 11. Those favoring the amendment are not interested in raising the salary of any one individual.
- 111. Of 30 cities the size of ours, Louisville pays the lowest salary to its Superintendent of Schoops. The result is that our superintendents are attracted by the larger salaries offered elsewhere, with a consequent loss to the children of Louisville.
- lv. It is increasingly difficult to secure able lawyers who will give up their practice in order to accept positions on the Court of Appeals with its small ramuneration.

In Kentucky salaries paid to judges of the Court of Appeals are the third lowest among those paid in any part of the United States.

Mr. Vance Armentrout explains the Absent Voter Amendment.

Mr. Vance Armentrout read the act which is an enabling provision under which the legislature may give permission to those persons who are unavoidably absent from the polls to cast their vote by mail, as provided by the legislature. upon question as to how the plan has worked where tried, Mr. Armentrout replied that it has been reported that it provides a loophole for fraudulent voters.

Miss Morel explains the Park Bond Issue.

Miss Morel, in reviewing the proposed Park Bond Issue made the following points:

1. The entire proposed scheme has been worked out taking into consideration the location of present playgrounds, and others in contemplation.

11. Provision has been made for both negroes and

whites.

111. The plan includes the development of playgrounds and parks already in existence and provides for an all year recreation program where possible.

Miss Morel explained that she was not free to name the sites under consideration as playground locations, but she said that those parts of the city which are not as yet provided for are under careful consideration.

lv. The Park Bond Issue provides for an Air Fort.

Miss Morel speaks on Incinerators.

Miss Morel explained that the 10 years' dream of the City Club seems about to be fulfilled in that the prospect of additional incinerators for the entire city is good. The new one, to be located on (Lexington Roads) will eliminate both the Grinstead Drive dump and the Ellison Avenue dump, she said.

Announcements.

Mrs. Zinsmeister, president of the League of Women Voters, requested that all members of the City Club familiarize themselves with the contents of the pamphlet by Mr. Armentrout entitled, "A Survey of the 1926 Legislature." A copy of the survey was given to each club member. Mrs. Zinsmeister requested a full attendance of members of the City Club at a meeting of the League of Women Voters to be held at the Unitarian Church on October 28th, at which time questions coming up at the November election will be discussed.

Mrs. Crutcher, Corresponding Secretary was instructed to inform Mr. Lewis that the City Planning Committee (Miss Breed, Chairman) would meet his request.

The President presented an offer from the Bureau of Commercial Economics, Washington, to furnish a lecturer, Miss Marguerite C. Hubbell, to give a talk on Quebec, free of expense, the cooperating club to supply auditorium, moving picture machine and operator, and victrola for folk songs. No action was taken.

The President also reported that Commander Richard E. Byrd, explorer, was announced to make a lecture of the Middle West, including Kentucky, November 15-28. This offered the City Club a means of raising money with a middinum of effort, and a letter had been despatched immediately, asking for further particulars. Mrs. Crutcher moved (Mrs. Peake) that a committee be appointed to secure information as to expense of speaker, hall, etc., and decide upon the feasability of the undertaking. Carried.

Club Rooms after expiration of present lease A letter was read from Mr. Kahn, Agent, asking whether the Club cared to re-lease quarters for another year upon expiration of the present lease December 1. Miss Morel reported an apartment, recommended by Mrs. New, at Third and York Streets, four rooms and bath, to be had for \$37.50 per month. The Committee considering quarters, Mrs. Almstedt and Mrs. Jenkins, suggested that other members of the Thipect rooms available in the Strand Building, as reported at a previous meeting. The President suggested calling a special meeting to discuss the matter, with possibly a visit to rooms under consideration.

City Planning Miss Morel, in the absence of Miss Breed, of the City Planning Committee, urged Club members to attend the hearing of a City Planning to come up in Court, Saturday, October 22, as the decision in this case might decide the fate of the temporary City Planning and Zoning Ordinance.

Luncheon Meeting Brown Hotel Saturday, November 12, 1927

The regular monthly luncheon meeting of the Louisville Women's City Club was held in the Louis XVI room of the Brown Hotel, Saturday, November 12, 1927, at 12:15 P.M.

The meeting was called to order by Mrs. Krieger, president. Miss Voegtle, secretary, being absent, the minutes of the October meeting were read by Mrs. Wood, and approved. Miss Boyle, treasurer, read her report, which was accepted.

The president announced that <u>Taxation</u> was the subject under consideration, and introduced as the first speaker Ex-Mayor Huston Quin. Judge Quin first called attention to two cardinal rules set by the State Constitution for cities of the first class:

I - The tax rate for city purposes, exclusive of schools, is limited to \$1.50 per \$100.00, the school tax limit is \$1.00, making the total limit \$2.50.

II - The limit for bond issues is 10% of the assessed property.
It is decreed that all taxes shall be uniform and assessed on a fair cash value of the property involved.

The funds received from the city taxes are first reduced by necessary apportionments to charitable institutions, and on the balance the city is economically conducted. Salaries are in many instances too low; particularly are policemen and firemen underpaid. Religious and educational institutions and public buildings are exempt from taxation, and new industries are granted five years' exemption.

The budget for each city department is submitted, carefully revised and pared as necessary (on the estimate of income compiled by the tax assessor) and recommendation is made to the Council and Board of Aldermen for approval. Apportionments made to the various city departments on the final budget are not interchangeable.

A sinking fund is established to meet interest on the bonded indebtedness and reduce principal. Louisville has the smallest debt in the country, approximately \$30,000,000 Money from licenses goes to the sinking fund, and in some years no apportionment is made from taxes received.

To consider complaints of excessive tax assessment a Board of Equalization is appointed, and it will go over individual tax statements with property-owners.

The president announced that Judge Quin would answer questions from the floor.

Mrs. Wehle asked; What becomes of Water Co. earnings Answer: The Water Co. is municipally owned (and the speaker wished that all other public utilities were so owned) and dividends on earnings are turned in to the sinking fund.

Mrs. Cheney asked: If the quarry should be given up, what would take the place of its earnings?

Answer: The city work-house issself-sustaining from the earnings of the quarry. If the present quarry should cease, the city would probably buy another quarry.

Mrs. Judah inquired about the exemption of religious property.

Answer: Churches are allowed each ½ acre in the city, 2 acre in the county free of taxation. Outside property, if used for educational purposes, is also exempt. If it is in separate locations, not all is tax-free. Taxes must be paid on that which is not used for church or education.

Mrs. Gifford asked: What proportion of the school allowance is demanded?
Answer: The schools usually get what they ask, but their demands are held in check by public opinion. Better school buildings are needed, and the public should be educated to accept a higher tax rate.

The second speaker, Mr. C. C. Hieatt, President of the National Association of Real Estate Boards, was then introduced. Mr. Hieatt said that City Taxation is a live subject over the entire country. As the bill for Federal taxes goes down, city and state taxes advance. The trend of population is toward the cities, (less than one-fourth of the people now live in the rural sections) and this increases the cost of municipal government.

It is therefore impossible to expect reduced city taxes. The revenue must be fairly raised and equitably distributed. Our methods of evaluation are antiquated. Taxes should be borne equally, with respect to the benefits received, rather than according to the ability to pay. It is desirable that all citizens share in public advantages - hence their responsibility for taxes. 75 % to 80 % of the tax receipts come from real estate, though wealth is now largely in other property.

Exemptions have grown to a pernicious degree. Our

State Constitution is antiquated. only public buildings should be exempt, with possibly church property used for religious purposes exclusively.

There is danger of taxing industries to death. Individuals should not ask special favors.
