BOARD MEETING

MINUTES

January 6, 1921

At a Board meeting of the City Club held January 6, 1921 Miss Lovell presided.

The minutes were read and approved.

A motion was carried that the Hospitality Committee make up from the Treasury any deficit occuring from the mistake in announcing the price of the Surprise Luncheon, fifth cents, instead of sixty cents as voted by the Board.

Mrs. Bayless reported trouble in getting the Health Committee to meet and asked that space in the Bulletin be given to urge the importance of an active Health Committee. Mrs Bayless said she considered it a most necessary piece of work for her committee, the following up of cases in the Prenatal Clinic at the City Hospital and looking after all children born in the Clinic.

Mrs Bayless also urged the necessity of a City Board of Health - and in this connection it was decided to have Mrs. Halleck, who represents the City Club in this matter, to ask the Mayor to join the Health Committee in a friendly suit to continue the law; in order that it may be determined, whether a City Board of Health is within the present law.

Mrs New's resignation as Chairman of the Foods & Markets Committee, being accepted, a motion was carried that the President abd retiring Chairman of the Foods & Markets Com. form a committee to choose a new Chairman.

It was moved and carried that any vacancies on the board be left till the regular election in March.

It was moved and carried that the next meeting be held the last Saturday in January. At this meeting the subject "City Government" was to be discussed and a well qualified speaker chosen to explain the different forms of City Government.

Mrs New reported that a special price of \$40. had been made by the Y.M.H.A. for the use of its Auditorium for an afternoon and evening performance of the Marionettes. It was stated that this attraction had been secured for \$400. The Board voted that all details of the Marionettes show be left to the President and Corresponding Secretary.

Miss Morel and Mrs Howard told of plans for a Health Demonstration week. It was moved and carried that future discussion in regard to this be postponed to the next board meeting.

BOARD MEETING

MINUTES

January 14, 1921

At a Board meeting held January 14, 1921 in the absence of the President, Mrs Halleck, the 1st Vice-President, occupied the chair.

Miss Booth, Chairman of the Membership Committee, asked that the board approve her sending 850 postal cards which she was to have printed and sent to members at once in an effort to bring the membership up to the 1,000 mark. A motion to this effect was carried.

It was moved and carried that the prices for the Marionettes Show be \$1.00 both afternoon and evening for adults and 50 cents in the afternoon for children, and that 500 tickets be printed for each performance. Also moved and carried, that all seats he reserved and that the W.K. Stewart Book Co. be asked to sell the tickets, children's ticket to be stamped with a rubber stamp.

It was moved and carried that any discussion

It was moved and carried that the Board endorse the plan for the Health Show, provided a practical plan of financing this could be brought to the Board, by Miss Morel and Mrs Howard.

It was moved and carried that a letter be written to the City Board of Safety, recommending a Department of Child Hygiene under the City Health Dept., urging immediate action.

LUNCHEON MEETING

MINUTES.

January 29, 1921

A Luncheon Meeting of the Women's City Club was held in the Y. M. H. A. Auditorium, January 29, 1921.

The meeting was opened by the President, Miss Lovell. Minutes of previous meeting were read and approved.

The Treasurer being absent there was no report Also no report from the following Committees:

Education, Health, Housing, Hospitality, Foods & Markets.

Prof. Toy of the Louisville Conservatory spoke for a few minutes on the importance of a City Orchestra and urged that a beginning be made at once toward securing same.

Mr. Temple Bodley was next introduced and spoke on City Government. Mr. Bodley mentioned three forms of City Government which are non-partisan: The Commission Form; The City Manager Form; and the Federal Form. He was not in favor of the Commission form, except as a relief from the partisan government controlled by political machines. Under the Commission form the city affairs are managed by a committee of 3 or 5, in whom all municipal power is placed, this plan, Mr. Bodley thought made for discontent, as power is in the hands of a few. The City Manager plan, which gives legislative

power to a small council, under an executive head, is a better plan and makes for a shorter ballot. The Federal Plan, was considered best by Mr Bodley, as it allowed a larger representation, having a number elected from each ward. Mr Bodley spoke of the fine work the women did in gaining freedom from political control for the schools and urged that they stand for a non-partisan form of city Government.

Miss Lovell said the women of the City must work shoulder to shoulder in helping to realize their ideals and making Louisville not only the cleanest and healthiest city, but also the best governed.

The Chairman of the City Betterment Committee next made her report. Out of fifty-three vaults found to be in bad condition, 32 notices were served on owners and finally warrants, but before cases came to court; permits were taken out for thirty-two toilets to be installed.

Miss Morel spoke of the rats on the Western dumps and said they were rapidly being poisoned. In another section ten overflowing vaults were reported and owners had secured permits to have toilets installed.

Miss Barbour of the Music Committee, told of the Concert at Y. W. C. A,, given by Mr. Toy and his orchestra under the City Club auspicies. She asked for more members for the Music Committee and urged a more generous support of entertainments arranged by the

Committee.

Miss Booth of the Membership Committee said during her absence in New York, Mrs. Michot would be Vice-Chairman. She reported 920 members at present.

There being no further business the meeting adjourned.

BOARD MEETING

MINUTES February 3, 1921.

A Board meeting of the City Club was held in the office February 3, 1921. Mrs Halleck, Vice-President, in the chair. Minutes of the previous board meeting read and approved. No report from the Treasurer.

The Finance Committee recommended that the dues be raised from \$1.00 to \$3.00. The Membership Committee recommended that dues be raised from \$1.00 to \$2.00. A motion made by Mrs. Settle, Chairman Finance Committee, that dues be \$3.00 was seconded, but lost by vote. A motion made by Mrs. Mengel that dues be raised to \$2.00 was seconded and carried. Mrs. Halteck suggested that a statement be made in the Bulletin and at the next Luncheon meeting, in regard to increased expenditures of the Club as well as the necessity of financing the Betterment work.

Mrs. Bloch, Chairman Nominating Committee, said several of the directors would stand for reelection.

It was moved and carried that cards be sent calling a meeting of the Highland Division for the purpose of electing a director to represent them on the Board or voting that they pass out of existence as a division of the City Club.

plans made for the Health Demonstration Week.

Miss Morel said a visit to the Mayor secured his approval of the plan.

Mr Grinstead of the County Court, promised the use of the Armory, lights and janitor.

Automobile Club thru Mr. Stewart, offered to have a demonstration of an intersection of streets. Miss Morel read a letter from the Russell Sage Foundation, asking if any advertising was to be done in commection with the display (?)

On a visit to the Board of Trade, Mr. Morrow, Secretary, told Miss Morel if she wanted financial assistance she should go to the Board of Directors at its next meeting.

It was learned that the Child Welfare exhibit cost between \$7,000 and \$10,000, but, Mr. Allen who had charge of it thought \$1,500 would cover cost of such a show as the Health Demonstration.

Ten cents as entrance fee thought sufficient.

Chairman of the Refreshments, Mrs. Dennis, thought

50% profit might be made from refreshment booth.

Miss Morel is Chairman, and Mrs. Howard, Vice-Chairman.

Other details of organization were left to them and it was stated that an office had been secured in the Republic building.

It was suggested that Mr. Stewart and Mr Wischmeyer be Finance committee and Mr. Allen of the
Publicity League, publicity man.

It was moved and carried that Miss Morel be asked to give her services for another six months, beginning February 1st, at the same salary. Miss Morel accepted.

Mrs James N Dennis was nominated from the floor their being no other nominations, the president announced the close of nominations and that a ballot would be prepared from them for the election at the March meeting.

Miss Morel siad there were 13,000 privy vaults in the city at the present time and that according to law, they must be closed after July 1, 1921.

The new Sewer Commission has made maps and plans for their work and are about to start actual operation in extending the city's sewerage system, which work will be financed by bonds.

Miss Morel said she was opposed to the fencing in of back yards with high board fences, as these frequently were used as screens to hide dirt and unsightly rubbish. She spoke of the excellent work being done by Mr Wischmeyer, the inspector of housing conditions in the city, and told of the investigation now being conducted of all places handling food. When these are found to fulfill requirements both as to cleanliness and purity of food, a gold star is awarded

Miss Morel and Mrs Howard then explained the extensive plans they had made for a Health Demonstration, by which it was hoped public interest would be awakened to the necessity of absolute cleanliness in the homes and premises as well we in the city in general, thereby raising the standard of sanitation.

It was proposed to have the Health Demonstration

Week begin April 21st. Miss Lovell spoke of it as a gigantic

piece of work but said it was entirely possible with a con
certed body of women working for it. Mrs Michot moved that

the City Club undertake to have this Health and Sanitation

Demonstration. It was seconded. Discussion followed.

Miss Dolfinger spoke in favor of it. Mrs Halleck told of

her approval of the plan but said the financing of the ex
hibit was an important matter as it was estimated to cost

\$2,000. Miss Simpson also spoke of the necessity of a

guaranteed fund. Mrs Michot's motion was amended to

read - That the City Club undertake a Health and Sanitation

Demonstration provided a guarantee fund could be secured

and presented to the Board within two weeks. Motion carried

as amended.

BOARD MEETING

MINUTES March 3, 1921

A Board meeting of the City Club was held March 3,1921 in the office. The minutes were read corrected and accepted.

No reports from the committees except the Membership Committee, which reported 968 members to date.

Miss Morel and Mrs Howard told of a visit to Mr. Morrow, secretary of Board of Trade, who informed them that the Board could not contribute a sum of money toward a guarantee fund for the Health Demonstration week planned for April by the Vity Club.

A discussion followed as to methods of securing the necessary guarantee fund. One way was suggested, that of asking the Standard Samitary Mfg. Co., to contribute the \$2500 thought sufficient. This plan was opposed on the ground that it would be placing too much authority in the hands of the Standard Samitary Co.

Another suggestion was that the exhibit being of paramount importance to the Health of the City, the city should be asked to finance it. Mrs Judah said the City Club was giving its City Betterment survey work about \$10,000 worth of work and that it seemed only fair that they should contribute the necessary money.

Mr Halleck said Mr. Ben Kaufman had offered lobby space in the Armory to the City Club during the Style Show

which space could be used for City Betterment Demonstration purposes. It was thought by members of the Board that an exhibit under such circumstances would be almost ignored.

During the discussion of financing the Health Exhibit as originally planned, Mrs Halleck pledged \$200 tow ward the guarantee fund, Mrs Ben Bayless \$100, Miss Alma Schmitt \$100, Mrs Howard \$100. Miss Morel that she could get \$500 from the city. Miss Morel and Mrs Howard were asked to prepare a more detailed plan of the actual exhibit; such as floor plan space, mapped off for various exhibits and what certain items of overhead expense would be. It was ascertained that the decorations and lights would be \$1175.

Miss Verhoeff urged the necessity of correcting the practice of dumping the garbage, which it was found was being done in some instances and spoke of a practical plan of garbage disposal being essential to the health of the city. Miss Morel said the city did not have the money to purchase an incineator at the present time.

Miss Lovell read a letter from Mr Hughes of the City Government Committee asking the City Club to be represented at their public conference and offering to supply questionnaires in ohder that the attitude of the Club members in this matter might be ascertained.

It was moved and carried that in order to further the work of the Vity Club, dues be graded as

follows: \$2, \$5, \$10, \$15, \$20, \$25, \$50, \$100.

No nomination to the board having been sent in to the City Club from the Highland Division, it was moved that the ballot be sent out containing the regular nominees and the Highland Division be asked to elect its representative later and announce same to the Board. Motion carried.

Meeting adjourned.
