We do not have any of Lewis' papers. The best collections of the papers of Meriwether Lewis are in two places. The Missouri Historical Society, Jefferson Memorial, St. Louis, has a collection of 2 volumes and 33 pieces, 1804-1835, including a journal of the expedition. The American Philosophical Society Library, 105 South Fifth Street, Philadelphia 6, Pa. has journals of the expedition and some miscellaneous material. There is also material at the Library of Congress but I do not know the extent of it. I hope this information will be of help to you. your are searching for anything specific, it would be well to tell the libraries when you write to them. I have searched through the publications of the Indiana Historical Bureau and several other Indiana publications with no success. I thought you might have special information files or access to publications on Indiana which might solve the problem. We have a letter of Meriwether Lewis to Major William Preston (1770-1821) dated 25 July 1808 which concerns in part a man named Brady whom they wished to help. From other manuscripts in this collection, I find that this man was H. Brady and in 3 January 1808 he was living in Indiana County. On 10 January 1808 he gives his address as Mahoning Mills, Indiana County. He was at least a rough contemporary of Lewis and Preston, which would mean that he was born about the last quarter of the eighteenth-century. Brady's wife was named Sarah and on Jan. 3, 1808 he states that he had a six month old daughter. I've found references to a Henry Brady in Executive Proceedings of the State of Indiana 1816-1836, Dorothy Riker, ed., Indiana Historical Bureau. Indiana Historical Collections, Vol. XXIX, 1947. On page 187 Henry Brady was commissioned Captain of the 17th regiment Aug. 22, 1821; page 515 Henry Brady commissioned a justice of the peace for Marion County, Aug. 14, 1828 and served until Aug. 1831. This may be the H. Brady of the Lewis letter. I would like to have as clear an identification of H. Brady as possible. Anything you may be able to determine concerning him will be greatly appreciated and will be most helpful. I am particularly interested in knowing his dates of birth and death with the places and anything which might indicate his association with Lewis and Preston. Both of the latter served in the Second Sub-legion of the United States Army. Brady may have been a soldier in the Army with them. About a year ago, The Filson Club was given a sizeable collection of Preston family papers, chiefly the papers of Major William Preston (1770-1821) of Virginia and Kentucky and his descendants. Among these papers were two letters of Meriwether Lewis with good content. I am currently in the process of transcribing and amounting these letters for publication in the Filson Glub History Quarterly. In the course of searching out information to clarify references in one of them, I find that it would be very useful to have the dates and places, if possible, for two marriages which must have taken place in Virginia. I have checked our collections for these facts, but without success and am turning to you in the hope that your extensive Virginia materials may contain these facts. Lewis' letter refers to Letitia and Elisabeth Breckinridge, daughters of General James Breckinridge of Botetourt County, Virginia. According to Orlando Brown, Memoranda of The Preston Family, Frankfort, Ky. 1842, page 4 Letitia married Col. Robert Gamble of Florida and Elizabeth married Gen. Edward Watts of Virginia, a lawyer and speaker of the Virginia Senate. Mary Selden Kennedy, Seldens of Virginia and Allied Families, vol. 1, page 96 states: Letitia Breckinridge born Oct. 26, 1791 in Fincastle, married Robert Camble of Richmond, Va. and later of Tallahassee, Florida. She died March 10, 1866. And on page 99: Elizabeth Breckinridge born March 31, 1794; married Cen. Edward Watts, a lawyer and Speaker of the Virginia Legislature. She died July 8, 1862. Meriwether Lewis' letter of July 25, 1808 would indicate that Letitia was married around June of 1808, perhaps in Botetourt County or in Richmond. Elisaboth was, at that time, unmarried. If it is at all possible, I am hopeful that the Virginia Historical Society would be able to supply me with the exact dates of these two marriages. I am also trying to determine whether William Preston's letter to Meriwether Lewis dated July 11, 1808 has survived in original form or a copy and would like to ask whether this letter might be preserved among your manuscript collections.

Do you think I should write also to the Virginia State Library in my search for this information?

I will appreciate any advice and information you may be able to provide. These facts will be very useful in clarifying the text of this letter and in preserving and making available a few more bits of the history of the Breckinridge family history.

While working for Colonial Williamsburg, I had occasion to meet you on a visit to Richmond with Dr. Edward Riley and Junius Fishburne. You kindly gave us a tour of the building and told us about your activities. I hope someday you may be in Louisville and that we may show you The Filson Club and its collections.
