Papers include Richard Clough Anderson correspondence, 1785-1826, accounts, 1777-1821, miscellaneous land papers, 1771-1823, and family correspondence of the Andersons and Lathams. Family correspondence includes letters from Anderson's children, Charles, John, Roy, Larz, Maria Williams, Sarah, Mary Louis, Robert, and William Marshall Anderson, and from his son-in-law, James Hall discussing their activities and news. Letters from Louisville and Jefferson County record social events of the day. Other correspondents include Daniel Gregg, R.G. Lewis, and John Cleves Symmes.
